

Purchase Area Emmaus Board Minutes

June 14, 2001

The Purchase Area Emmaus Board of Directors held their monthly meeting on June 14, 2001 at the First United Methodist Church in Mayfield, KY. Those in attendance were: Tommy Waldrop, Keith Maness, Steve Abell, Rev. David Roos, Pat Massa, Greg Gunter, Brenda Southwick, Ruthie McQuady, Lynda Cochrum, Charlie Baker (Lay Director Walk #61), Roxanne Wright (Lay Director Walk #62), Debbie Bushart (Lay Director Walk #63).

David Roos opened the meeting with prayer.

Keith Maness gave the devotion on forgiving self, just “give it to Christ”.

Minutes were read by Charlie Baker, and Pat Massa moved to accept minutes with Greg Gunter seconding the motion.

Greg Gunter gave the treasurer’s report. The balance on hand as of May 30, 2001 was \$3624.25 Steve Abell moved that the report be accepted and David Roos seconded the motion.

Tommy led the discussion on the book table during the walks. During one of the last walks there was a shortage of \$60. Since the walk, the bookstore was repaid \$30 of the \$60. Tommy suggested that an additional person be added to the team for the walks to help with agape and attend the book table from Saturday morning until Sunday afternoon when the book table is taken down. The Lay Director of a walk would announce that the book table would be opened after lunch on Saturday. Whenever the table is unattended, a sheet will be placed over the items until someone is there to assist with sales. Brenda made a motion to add an agape person to the team starting with the fall walks. Greg Gunter seconded the motion.

Tommy said Bobby Warren had been asked if we could build a storage building at B.A.S.I.C. for Emmaus. There is so much that has to be transported back and forth, and Bobby was receptive to the idea provided that the building was in keeping with the décor of the other buildings at B.A.S.I.C. Tommy will talk with Bob Alexander to estimate the cost of the storage building and get back with the board.

The next Emmaus Board meeting will be on July 5, 2001 at First United Methodist Church in Mayfield, KY

Tentative dates for the 2002 Emmaus Walks are: April 11-14 for the men and April 18-21 for the women. Lynda made the motion for Tommy to check with Bobby Warren to see if these dates are available and Pat Massa seconded the motion.

Debbie Bushart advised that a new songbook was in the works for the Chrysalis and Emmaus communities and that the Chrysalis board had agreed to pay for ½ of the cost up to \$500. They estimate that the books will cost about \$1 each to print and need approximately 750. She asked

if the Emmaus Board would agree to pay for part of the cost. Lynda made the motion that Emmaus pay ½ of the cost for the books up to \$500. Greg Gunter seconded the motion.

Ruthie McQuady made the motion that the minutes of the Board Meetings be posted on the website and Greg Gunter seconded the motion. Keith Maness said that he would be glad to put them on the website but asked that they be given to him already typed. A motion was made by Pat Massa that Jack Peebles type the notes and forward to Keith Maness for posting on the website.

Brenda Southwick gave the closing prayer and Tommy Waldrop adjourned the meeting.
